### **Fellowship Overview**

The Cincinnati Children's Administrative Fellowship is a one-year project-based experience offering the opportunity to develop an understanding of the administration and operations of a leading pediatric and academic medical center. Fellows will have the opportunity to lead and participate in real-time strategic, operational, and financial projects across the organization, while also building relationships with team members and leaders throughout Cincinnati Children's.



### How to Apply?

Applications for the Cincinnati Children's Administrative Fellowship can be submitted in two ways:

- Use the online National Administrative Fellowship Centralized Application Service (NAFCAS)
- Submit required materials detailed below to AdminFellowship@cchmc.org. Required materials include (1) a one-page resume, (2) three letters of recommendation, (3) a graduate grade report or transcript, (4) a one-page personal statement (750 words or less) that includes the following:
  - Why are you interested in working at a pediatric institution, specifically at Cincinnati Children's?
  - How will the knowledge and experience you gain through a pediatric fellowship with Cincinnati Children's help you accomplish your personal, educational, and/or professional goals?
  - How has one or more aspect(s) of your identity (ex. culture, race, ethnicity, gender identity, religion, family structure, etc.) contributed to your life experiences?

### **Fellowship Experience**

- Administrative Fellows work closely with leaders on a wide variety of impactful projects throughout Cincinnati Children's
- Direct mentorship and coaching from a Preceptor and an Executive Sponsor

### **Previous Project Work**

- Co-led the launch and opening of our new Critical Care Building. Assisting with issue reporting, facilitating pathways for patients/departments being moved into new building, and conducted tours for staff at the hospital.
- Served as Project Manager in the initiative to reduce Pyxis stockouts by 50% across all intensive care units (ICUs) at Cincinnati Children's. Further, developed the template project plan for executing the build and hard implementation of a 2-bin Kanban system for the institution. The system seeks to ensure optimal availability of inventory, mitigation of abrupt shortages, and overall customer satisfaction.
- Project member for improving emergency department to inpatient flow: goal of decreasing "boarding time" between decision to admit a patient in the ED and the patient being in an inpatient room by utilizing quality improvement methods and interdisciplinary collaboration across the hospital system.
- Served as project lead and communication liaison for Gallery at Gumbo art exhibition. Paired local professional artist with aspiring youth artists from Cincinnati public schools and developed a proposal for continuation of partnership and create model for future opportunities of similar nature
