QUALIFICATIONS:

Required:

- Master's degree in Epidemiology or Public Health with epidemiology training and experience
- Minimum three years experience in epidemiology methods, application or research
- Knowledge and/or capability to perform meta-analyses
- Demonstrated successes in working as part of a team
- In-depth knowledge of computerized, thorough, efficient, and focused reviews of the medical literature, including a familiarity with private and public epidemiologic resources and databases [e.g., bibliographic software, web-based search engines (OVID, PubMed, EBSCO)]

Preferred:

- PhD in Epidemiology or Public Health with epidemiology training and experience
- Experience in healthcare related evidence-based initiatives or quality improvement

MAJOR DUTIES AND RESPONSIBILITIES:
